VP – Jim: Opened with welcome. The concession bank account has been updated to reflect the following: **REMOVE** Rose Mayr and Mark Gocken; **ADD** Samantha Desmarais

Elections will be held on March 6, 2016. Merriann Frederick is the only one that submitted a letter of intent for the secretary position. The Vice President position did not receive a letter of intent. Jim D'Errico will continue until someone is appointed. We are now within the 30 day period and no changes will be made. The Vice President position will now become an appointed position.

No one proposed any By-Law changes. The by-laws will remain the same.

Committee Reports

Travel Registrar – Boys & Girls: 14 new registrations for spring: 9 girls & 5 boys (17 at this time last year)

Travel Registrar & bookkeeper: 12 of the new players are paid in full, 2 are on payment plans. We dissolved the U18 girls team & moved 4 girls to the boys team and 4 girls to Coach Mann's team.

Academy Bookkeeper provided through Jim: JR Academy has 19 registered. 14 are paid in full; 4 are on payment plans; 1 will pay first night of JR academy.

SR Academy has 22 registered. 15 are paid in full; 2 are on payment plans; 5 will pay the first night of SR academy.
